DESCRIPTION OF WORK:	The project shall consist of providing all materials, equipment, and labor necessary to install the work approximately defined as: Division I = RISE Participating Items and Division II = Non-Participating Items: Division I scope of work shall include strip, stockpile & re-spread topsoil of street construction limits & borrow area; excavate borrow area, place material & build street embankment; remove, salvage & re-install 60 LF of existing storm sewer pipe, connect storm sewer to existing curb inlet box, furnish & install 13 curb intakes, 1 Storm MH, approximately 220 LF 15" dia., 44 LF 18" dia., 1276 LF 24" dia., 409 LF 30" dia., 320 LF 48" dia., & 196 LF 72" dia.
