<b>DESCRIPTION OF WORK:</b>	The project shall consist of providing all materials, equipment and labor necessary to install the work as defined as follows: 2159LF of Sanitary Sewer (size 8-inch – 15-inch, 1620LF of Sanitary Sewer (10-inch, Pipe Bursting), 13 Sanitary Sewer Manholes, 112 LF of Cured in Place Pipe (CIPP) Lining (size 18-inch), 1772 LF of Pipe Cleaning and inspection for rehab. (size 8-inch – 15-inch), 1207 UNITS of Clearing and Grubbing, 390 LF of Sanitary Sewer (size 12-inch RJ with Casing), Traffic Control, Mobilization, Street Patching, Dewatering, Railroad Protective Insurance, and other associated appurtenances and miscellaneous work items.  All Work and equipment is to be in accordance with the Plans, Specifications and Contract Documents on file with the City Clerk of the City of Tiffin, Iowa, which are by this reference made a part of this Notice as though fully set out and incorporated herein.
<b>SALES TAX EXEMPTION</b>	<b>The Bidder is eligible to receive an exemption from the State of Iowa Sales Tax. The City expects the Contractor to obtain the Sales Tax Exemption from the City. State of Iowa Sales Tax shall <u>NOT</u> be included in the bid.</b>
<b>PREFERENCE</b>	By virtue of statutory authority, a preference will be given to products and provisions grown and coal produced within the state of Iowa.
<b>BID GUARANTY:</b>	Bid security in the form of a cashier's check or certified check drawn on a state-chartered or federally chartered bank, or a certified share draft drawn on a state-chartered or federally chartered credit union, or a bidder's bond with corporate surety satisfactory to the City, in the amount of 10% of the bid.
<b>COMPLETION DATE:</b>	Work shall commence within ten (10) calendar days after receipt of the written "Notice to Proceed". All work shall be completed by <b>September 1, 2024</b> subject to any time extension that may be granted by the Council.
<b>PERFORMANCE/ PAYMENT /MAINTENANCE BOND:</b>	One hundred percent (100%) of the bid, with a maintenance period of <b>three (3)</b> years from the time of final project acceptance by the Owner.
<b>PAYMENTS:</b>	Monthly estimates equivalent to ninety-five percent (95%) of the Contract value of the work completed during the preceding calendar month with 5% retainage. Remaining retainage, if any, will be paid within 30 days after final acceptance by the City.
